The Association issued reminders Oct. 30 to constituent and component societies regarding ADA resources and assistance.




'It's not loyalty but principle that drives our policies'

Dr. Faiella charts course with datadriven policies for presidential year

San Francisco-There are great challenges facing the profession of dentistry, and the ADA's future success will hinge on its ability to see beyond the horizon and find solutions.

"The challenges we face as an Association will require us to think and interact in ways that push us beyond our past efforts; and although we have already taken steps in that direction, few would agree that our work is complete," Dr. Robert A. Faiella said to the ADA House of Delegates Oct. 23 after the Osterville, Mass., periodontist was in-

stalled as the 149th president of the American Dental Association.

"We are all engaged in an extraordinary and dynamic profession that will continue to demand our attention," he added. "As leaders, none of us have all the answers, but we will find them as work together over the next year."

In his address to the House, Dr. Faiella-who completed postgraduate training at Harvard Medical School—reflected on the ornate gates of Harvard Yard through which new and graduating students pass, and the inspiring inscriptions they convey.

Champions of Give Kids A Smile feted at 10th anniversary gala

San Francisco—Just as the ADA's Give Kids A Smile program has become synonymous with a spirit of giving, so too have the names of several champions of the program over a decade of providing free dental treatment to children who need it.

For their tireless efforts, three of those champions were honored Oct. 22 at the ADA Foundation's Give Kids A Smile 10th Anniversary Gala.

Give Kids A Smile is the ADA's premier national access to care program that provides free dental screenings, treatment and education to underserved children. The ADA launched GKAS a decade ago, inspired by the successful local programming efforts of Dr. Jeffrey B. Dalin of St. Louis.

Dr. Dalin is one of the three recipients of the first GKAS Smile Champion Awards, bestowed at the gala. The two other honorees are Henry Schein Chairman and CEO Stanley M. Bergman and Henry Schein's Vice President of Global Professional Relations Steven William Kess.

They were feted before an audience that included then-ADA President William Calnon, then-President-elect Robert Faiella and

several other ADA luminaries, including trustees and Board officers. Dr. Faiella was installed as president on Oct. 23. Each received a commemorative crystal trophy with a special inscription.

Over the course of a decade, GKAS has provided dental treatments for nearly 4.5

million children through the efforts of nearly half a million volunteers, including 100,000 dentists and 335,000 other volunteers ranging from dental hygienists, dental technicians, teachers, parents and school nurses to other community health professionals. Since the establishment of the Give Kids A Smile Fund, the ADA Foundation has made grants in support of the program in excess of \$1 million.

Dr. Dalin received the Smile Champion Award inscribed "Outstanding Oral Health Professional Volunteer."

In 2001, Dr. Dalin co-founded Give Kids A Smile St. Louis, a program designed to deliver full-service dental care to children without access to dentistry. In February 2002, his dream became reality with the first St. Louis Give Kids A Smile Clinic. Since then, more than 9,500 St. Louis-area children have received more than \$4 million worth of dental care in 21 two-day clinics. Following the success of the program in St. Louis, Dr. Dalin shared the concept with the ADA and the national Give Kids A Smile program took form.

Dr. Dalin has been in private practice in St. Louis for 32 years. He has published articles and lectured on many topics related to oral health, and he has won dental journalism awards from the International College of Dentists; Awards of Merit, Distinguished Service Awards, and the Gold Medal Award from the Greater St. Louis Dental Society; a Dentist of the Year Award from the Missouri Dental Association; and a Presidential Citation from the American Dental Association. He is a 1980 graduate of Indiana University School of Dentistry and a former clinical

instructor in the Department of Operative Dentistry at Washington University School of Dental Medicine.

Mr. Bergman received the Smile Champion Award inscribed "In Appreciation of Exemplary Leadership."

Other awards that Mr. Kess has won include

the Distinguished Service Award from Dental Volunteers for Israel (2010); the Lifetime Achievement Award for Outstanding Public Service from the National Institute of Dental and Craniofacial Research (2010); a Distinguished Service Award from the Brownsville Medical Service (2009); a Presidential Citation from the American Dental Association (2008); and honorary membership in Alpha Omega (2008).

In 2006, the ADA selected Mr. Kess to serve as chairman of the National Advisory Board of Give Kids A Smile, a position he held until 2012.
